Notes:

- 1) The international joint rates herein are applicable to a Non-Term Shipper who specifies the international joint service via a Notice of Shipment and to a Term Shipper for volumes Tendered in excess of the Contract Volume in accordance with Term Shipper's Contract.
- 2) Volumes Tendered at the Sour Lake interconnect facility will be charged an additional [U] US\$0.9155/m³ ([U] US\$0.1456/bbl) for volumes Delivered at such facility.
- 3) There will be an Abandonment Surcharge of [U] CAD\$0.378/m³ ([U] CAD\$0.060/bbl) applicable to all Shippers in accordance with the determination of the Abandonment Charge as set forth in CER Tariff No. 78.

Joint Routing:

South Bow GP (Canada) Ltd. - Hardisty, Alberta to International Boundary at or near Haskett, Manitoba connecting to;

South Bow (USA) LP - International Boundary at or near Haskett, Manitoba to Port Arthur and Houston, Texas.

Exceptions:

- 1) Exception to CER Tariff No. 72, Article 9, Payment of Tariff Tolls and Other Charges and Lien for Unpaid Charges: For the purposes of the international joint uncommitted rate, FERC No. 5.7.0, Item 9, will apply. Abandonment Surcharge remains in accordance with CER Tariff No. 72.
